Mayor Altnauer said the food prep at events only and a home office at 504 Indian Creek. Kevin Armstrong stated that was correct. He said he was also looking for a building in the future to use. Tony Sells made motion to approve the business license for KMA Events LLC as personal Chef and home office with stipulation no food prep on site. REQUEST FOR SPEEDHUMP – CHARLES ADKINS – 256 W MAIN ST.

Mayor Altnauer said Mr. Adkins lives in the curb near the Falls Subdivision and complained about how fast people come in the curb. Tony Sells said there are four speed humps up towards his house. Mayor Altnauer stated we owe two speed humps now. He said we get lots of complaints about this area. He said we cannot just put them anywhere. Brandie Owens stated it is bad in this area.
